CREDIT AGREEMENT – PLEASE READ AND SIGN BELOW

1. **TERMS OF SALE:** Unless otherwise agreed, Jubitz Fleet Services accounts will be invoiced twice a month (through the 15th and last day of the month) and payment shall be by electronic funds transfer (EFT). Each invoice is DUE and payment must be actually RECEIVED at our designated payment location 15 days from invoice date. Jubitz Service Center accounts will be invoiced at time of service and payment is DUE at our designated payment location by the 15th of the following month. Payment for all other products and services is due 30 days from Transaction Date unless otherwise specified by Jubitz. Billing frequency may vary by invoice, product, amount or billing division. Acceptance of payment(s) for past due amounts shall not affect the terms of this agreement. ANY SPECIAL BILLING CONSIDERATIONS MUST BE AGREED UPON IN WRITING BY JUBITZ. Cash discounts are not offered unless specified on the invoice. All payment shall be in U.S. dollars.
2. Fuel prices are subject to change at any time without notice. Fuel purchased from the PACIFIC PRIDE cardlock system shall include applicable state fuel taxes unless exempt from tax pursuant to Oregon Use Fuel Tax. Exemption from state taxes shall be granted only upon proof of exemption as required by Jubitz. Customer shall retain full responsibility for payment of taxes should a taxable use arise, including cancellation or expiration of exemption permits.
3. Past due balances are assessed a FINANCE CHARGE of 1½% per month (ANNUAL PERCENTAGE RATE 18%) or the maximum rate authorized by law whichever is lower, MINIMUM FINANCE CHARGE \$3.00. Pending credits from product returns, exchanges, repurchases or otherwise shall not be deemed payment unless and until such credits have been approved by Jubitz and are reflected on customer's invoice or statement.
4. Accounts may be placed on hold or on a C.O.D./cash only basis at our option without advance notice. In no event shall Jubitz be liable for any consequential damages or other loss which may result from the exercise of its option under this section 4.
5. In the event any account is not paid when due, the prevailing party shall be entitled to recover reasonable attorneys fees and any court costs, including costs of appeal or other review. In the event your account is placed for collection with a collection agency, you agree to pay any collection fee that may be assessed in addition to all other amounts owing. Parties hereby acknowledge making this agreement in the State of Oregon and agree that jurisdiction and venue for any suit brought to enforce any term(s) of this agreement and/or any other action(s) arising from or as a result of this agreement shall be in Multnomah County, State of Oregon.
6. Jubitz shall be entitled to rely upon verbal order or signature by you or your apparent representative on any invoice for any sale or service performed, and such authorization is presumed to establish your acceptance of and agreement to comply with the terms and conditions set forth herein, without exception. USER AGREES TO PAY FOR ALL MOTOR FUEL WITHDRAWN BY USE OF CARD(S) AND ALL NON-FUEL TRANSACTIONS BY USE OF FUEL CARD(S) ISSUED TO USER, REGARDLESS OF WHETHER OR NOT SUCH CARD(S) HAVE BEEN LOST OR STOLEN WITH OR WITHOUT USER'S NEGLIGENCE.
7. This agreement shall be subject to acceptance by Jubitz Corporation. Payment terms and payment method subject to credit approval. Jubitz shall have the right to electronically deposit any check payment received.
